
EKATI WORK IN NWT RE-DIRECTED AFTER PLANT FIRE

Due to a recent fire at the main plant at the Ekati Diamond Mine in the NWT, all work on the project being done by Gisborne's CGT Industrial Division was temporarily shut down and the workforce was re-deployed to assist with the clean up and repair of the damage to the plant. This process is estimated to take approximately 3 months after which time the crews will return to the FINES project that we were originally contracted to construct.

One of the challenges for the crews is that up to this point, due to the chemicals and residue from the fire, full hazmat suits must be worn at all times while working on the plant restoration.

GISBORNE COMMENCES WORK FOR COMMISSIONING OF 2 - 40 MW BIO-MASS POWER PLANTS IN BRITISH COLUMBIA

Gisborne's Industrial Construction Division was awarded 2 contracts to supply the workforce to assist with the commissioning of two 40 MW bio-mass power plants in British Columbia. We were involved in the construction of both plants and as a result, the owner requested us to assist them with the commissioning. The plants are located in Fort St James and Merritt. Our teams are working under the direction of Iberdrola management with the goal being to have the plants commissioned and connected to the BC Hydro grid in 2017.

CONSTRUCTION WORK AT MERRITT BIO-MASS PLANT NEARING COMPLETION

Gisborne's Industrial Construction Division is nearing completion of the Balance of Plant work for the construction of the 40 MW Bio Mass plant in Merritt BC. This complex installation involved a labyrinth of piping and specialized welding. Led by our site team of **Wayne Reville**— Superintendent, **Al Ward**—General Foreman, **Matt Sarkor**—Senior Project Coordinator, **Valerie Lefebvre**—Senior Project Coordinator & **Rob Lizotte**—HSE Manager, our crew of 60 plus skilled tradespeople and support personnel have done an excellent job of constructing a quality project safely while meeting the client's rigorous installation standards.

With 48 projects either underway or scheduled to start in the near future, our BC and Alberta Fire Protection Divisions continue to be very busy. CHALLENGING THE 'MYTH' OF KEEPING

EMAILS BRIEF - Excerpted from Globe & Mail article

A key rule for e-mail has been to keep it brief. The recipients are pressed for time – and perhaps, on their mobiles, cramped for visual space – so keep it to a sentence or two.

Wrong, says productivity expert Cal Newport, the author of *Deep Work* and professor of computing science at Georgetown University. He says you should write longer e-mails, ironically in the interest of saving time and aggravation.

When sending or replying to an e-mail, you should identify the goal this e-mail is trying to achieve. An example might be arranging a meeting or grabbing a coffee with a collaborator. The goal, therefore, is to synchronize a plan for such a meeting with a minimum of back-and-forth e-mails. Instead of just suggesting getting together – or responding to such a suggestion with "sure" – come up with a process that gets you and your correspondent to that goal while keeping messages to the minimum—include key items to be discussed along with suggested time and location for the meeting.

This will initially take you longer, but that doesn't matter because you are dramatically reducing the number of times you will receive, open, and have to reply to a growing email chain to clarify. details that could have been addressed in the first email.
