## TECK Elkview Coal Production Increase Project

Located in the East Kootenay region of British Columbia, approximately 160km NE of Cranbrook, this project is a brownfield coal mining and processing plant upgrade increasing the capacity of the Elkview Operations (EVO) processing facility.

The Project covers the upgrade to existing conveyors, chutes and feeders and installation of additional processing equipment within the processing plant to increase production to achieve an annual clean coal production of 9.0Mt/a.

The Works generally comprises of Structural, Mechanical Piping and Materials Handling Installation on the Elkview Production Increase Project.



## KEMESS MINE WATER TREATMENT PLANT

Gisborne is also constructing the water treatment plant at the **Kemess Mine** in Central British Columbia. Centerra is in the process of re-starting the mine and the first part of the process is to construct the water treatment plant which will remove heavy metals and selenium from the site and is a requirement of the permitting to re-open the mine. Work started in April of this year and we expect to be on site until late October of 2019 to complete this phase of the project.

## FIRE PROTECTION DIVISION UPDATES

With the legalization of cannabis in Canada recently, there is an increasing demand for fire protection systems for the infrastructure required to grow and produce these products. Gisborne's BC and AB divisions have been awarded several large design and install contracts for some of the major companies in both provinces which is another example of various industries looking to Gisborne for quality installations for their projects.

Our Alberta division is in the process of completing the installation of a large system for Cavendish Farms in Lethbridge AB. This project has been over 1 year in duration and is one of the larger commercial installations we have completed in Alberta in recent years.

The condo market in BC has not slowed down at all and we have booked work for the next 2–3 years for design and installation of systems in high rise towers throughout the Lower Mainland alongside commercial and institutional project work.

With 42 current apprentices (11 in AB and 31 in BC) we are continuing to 'grow our own' in terms of developing future journeymen and leaders in both of our fire protection divisions.

## GISBORNE'S GREEN HAND/ GOLD HAND PROGRAM

The Green Hand / Gold Hand Program is applied across all Gisborne construction operations. The program requires the unreserved commitment of Management, Supervision, direct and Subcontractor workforce to assure its effectiveness. All field workers new to a project (Green Hands) and supplying labour and trade services to Gisborne, shall be supplied with a site orientation, training and mentorship in pursuit of worker development towards an experienced "Gold Hand" accreditation for each worker.



By actively engaging all project members in the mentorship, training and visible identification of Green Hand workers, new and/or inexperienced personnel to our industry shall be afforded the benefit of guidance from experienced supervision and co-workers. This initiative is in keeping with Gisborne's culture of safety and continues to demonstrate our ability to lead the industry in reducing workplace incidents. Through the active participation in the HSE program and the demonstration of competency in the execution of the work, a Green Hand worker may realize Gold Hand status through their tenure with Gisborne.
